USER GUIDE

PORTFOLIO OVERVIEW

The Portfolio Overview is intended to provide a high level summary of the structure and functions of the portfolio, resourcing for agencies and measures in the 2001–02 Budget.

AGENCY BUDGET STATEMENTS

A set of agency budget statements is presented for each agency within the portfolio and each set comprises up to four sections common to each agency, followed by appendices. The section titles and structure for each set of statements are as follows:

Section 1: Overview, appropriations and budget measures summary

This section details the link between the resources appropriated and their application to the outputs which contribute to the achievement of outcomes and the impact of any Budget Measures.

Section 2: Outcomes and output information

This section details planned government outcomes and the contributing administered items and departmental outputs.

Section 3: Budgeted financial statements

This section contains the budgeted financial statements in accrual format covering budget year, previous year and the three outyears for each agency.

Section 4: Purchaser/provider

This section is presented for those agencies that have entered into purchaser/provider arrangements with other agencies.
